- Confirmation of enrollment, in a 2nd year, accredited institution for study on a full time basis

**PROGRAM DETAILS**

- *A total of five Credit Union scholarships will be provided in 2026.*
- *Scholarships are for students that have been accepted at an accredited university or college for their second year on a full-time basis.*
- *Each successful student will be granted \$1,000 toward their 2026 fall semester.*
- *Scholarship submissions will be required no later than 5:00 pm on June 5th.*
- *A decision on the successful applicants will be made by a committee appointed by the Police Credit Union in conjunction with the Board of Directors, no later than July 10th each calendar year.*
- *Applicants who receive a scholarship will also be required to submit or have a digital image of them captured by authorized staff of the Police Credit Union for use on the Police Credit Union's website and in newsletters along with their name.*
- *Students cannot receive more than one scholarship from the Police Credit Union throughout their educational career.*
